### **Future direction and goals of Community Education**

Dr. Jefferson reviewed the school's capital warrant articles. The committee will decide at the March 14<sup>th</sup> who will speak to each individual school article at town meeting. The committee discussed the Capital Planning and Investment Committee's municipal building proposal and chose to take no action at this time.
